ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

EFFECTIVE DATE

09/07/00

The name of this corporation is ACTIVE ACCOUNTS INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III - PURPOSE
