## ARTICLES OF INCORPORATION

OF

#### BRODY PROPERTIES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby comes to form a corporation under the laws of the State of Florida, Florida Statutes 607.001 et. seq., and the corporation so formed shall be for profit.

## **ARTICLE I - NAME, OFFICE & MAILING ADDRESS**

The name of the corporation shall be: BRODY PROPERTIES, INC., located at 13320 SW 128<sup>th</sup> Street, Miami, Florida 33186.

# **ARTICLE II - TERM OF EXISTENCE**

This corporation is to exist perpetually and shall commence at the time of filing these Articles.

# **ARTICLE III - NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation shall be the development of Residential and Commercial Real Estate within and without the United States; as well as any other business now or in the future lawful in the State of Florida or any other jurisdiction where the corporation transacts business. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property or instruments to secure the payment of corporate indebtedness.
