The undersigned subscriber to these Articles of Incorporation, Tom Dalia, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**CORPORATE NAME**

The name of this Corporation is DALCOM, INC. The principal office and mailing address of the corporation is 4201 S.E. 2nd Avenue, Cape Coral, Florida 33904.

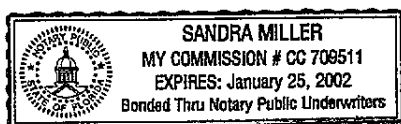
