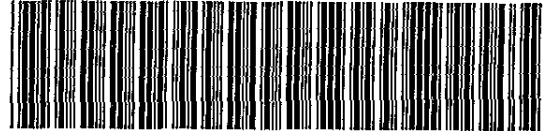

Article II. The Articles of Incorporation of the Corporation were filed on September 6, 2000 with the Secretary of the State of Florida.


Article III. Article 1 - Corporation Name and Article 5 - Principle Office are hereby deleted in their entirety and replaced respectively with the following:
