The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is DM 100, INC. and its principal office and mailing address is 2000 North Florida Mango Road, Suite 200, West Palm Beach, FL 33409.

**Commencement of Corporate Existence**

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

By-Laws


