

**ARTICLES OF INCORPORATION OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is Tech-On-Site Services, Inc.

**ARTICLE II**

The existence of the Corporation shall begin on September 6, 2000.

**ARTICLE III**

The Corporation may engage in the business of testing sites for wireless communications and any other lawful business.

**ARTICLE IV**

The street address of the principal office of the Corporation is 4027 Palau Drive, Sarasota, Florida 34241.

**ARTICLE V**

The maximum number of shares this Corporation is authorized to issue is one thousand (1,000), all of which shall be Common Shares. **ARTICLE IX**


The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
