

**ARTICLES OF INCORPORATION OF**  
**DANIEL S. LIEBOWITZ, P.A.**

The undersigned, acting as Incorporator pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE I NAME**

The name of this professional association is Daniel S. Liebowitz, P.A.

**ARTICLE II DURATION**

The period of its duration is perpetual, beginning from the date these Articles are filed with the Department of State.

**ARTICLE III NATURE**

The general nature of the business to be transacted by this corporation is to engage in the practice of law.

**ARTICLE IV CAPITAL STOCK**

This corporation is authorized to issue 100 shares of common stock, all of one class, at a par value of \$1.00.

**ARTICLE V PREEMPTIVE RIGHTS**

A. Each of the shareholders agrees not to sell, transfer, pledge, assign or otherwise in any way dispose of his or her shares unless and until he or she shall have offered to sell his shares to the other shareholders at a fair and reasonable price.

B. All additional shares of common stock issued by the corporation shall be subject to the same restrictions regarding transferability as the initial stock.

C. The holders of common shares shall be entitled to purchase newly issued stock proportionate to their respective holdings prior to the stock being offered to outside subscribers.



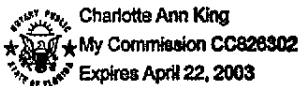
