ARTICLE I

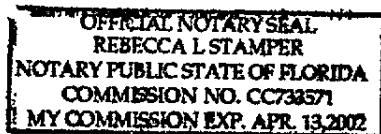




