**ARTICLE I**

The name of the corporation is SOUND ADVICE OF ARIZONA INC. (the "Corporation").

**ARTICLE II**

The address of the initial principal office and the mailing address of the Corporation is 1901 Tigertail Boulevard, Dania, Florida 33004.

**ARTICLE III**

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Stock having a par value of \$0.01 per share.

**ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or

**ARTICLE VI**

**ARTICLE VII**

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
