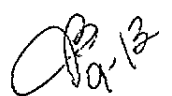

The undersigned incorporator JENNIFER A. GRAVES for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

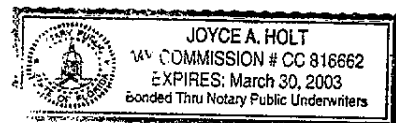
