ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is **X-TREME POWDER COATING, INC.**

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - CAPITAL STOCK

ARTICLE IX - AMENDMENT

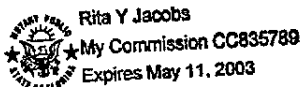
