**ARTICLES OF INCORPORATION**

**OF**

**ARTICLE I**

The name of this corporation is RED TRUCK TOWING INC., whose principal address is 3784 S.W. 60th Terrace Davie, Florida 33314

**ARTICLE II**

The general nature of the business to be transacted by this corporation is to engage in Towing, a business permitted under the laws of the State of Florida.

**ARTICLE III**




