ARTICLE I - NAME

The name of this corporation is PARA-MED, INC. located at 19 WEST FLAGLER STREET, SUITE 906, MIAMI, FLORIDA 33130.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.
