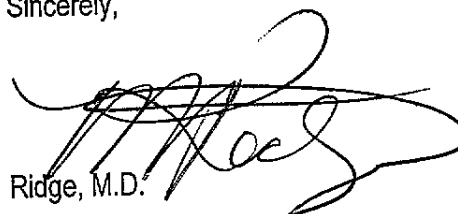

**ARTICLE I**

The name of the corporation shall be RECORDS DEPOSITION SERVICES, INC., and its mailing address shall be 1126 S. Federal Highway, Ste 332, Ft. Lauderdale, FL 33316.

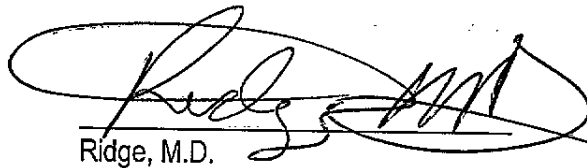

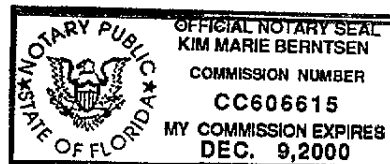

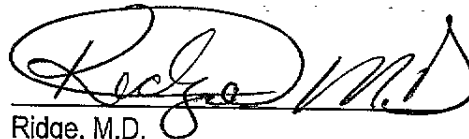
