**ARTICLES OF INCORPORATION**  
of

**Article I – Name**

The name of the Corporation shall be **TROWEL PROS INC.**

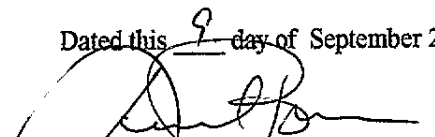
