
Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The Corporation is amending the Articles of Incorporation to change its name. The Articles of Incorporation shall be amended to state: "The name of the Corporation is Florida Local Interactive, Inc."

SECOND: If an amendment provides for an exchange, reclassification or cancellation of issued shares, provisions for implementing the amendment if not contained in the amendment itself, are as follows: Not applicable
