In compliance with the requirements of F.S. Chapter 607, the undersigned being a natural person, does hereby act as incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a professional service corporation.

ARTICLE I

The name of the corporation is **THE FORD GROUP L.M.T., P.A.**

ARTICLE II




**DESIGNATION AND ACCEPTANCE OF REGISTERED
