ARTICLES OF INCORPORATION

OF

DAMCO INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation

ARTICLE I NAME:

The name of the corporation shall be DAMCO INC.

ARTICLE II PRINCIPLE OFFICE:

The principle place of business and mailing address of this corporation shall be:  
910 NW 6 Avenue, Crystal River, Florida 34428. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III SHARES:

The number of shares of stock that this corporation is authorized to have outstanding at any one time is shall be 1000 shares of \$1.00 par value common stock. All of said stock shall be payable in cash, or property other than stock or securities, in lien of cash, at a just valuation to be determined by the Board of Directors of this corporation

ARTICLE IV TERM OF EXISTENCE:

This corporation will exist perpetually.

The corporation shall have one director initially.

C. The officers shall be elected at the annual meeting of the Board of Directors or as provided in the By-laws.

#### ARTICLE VIII AGREEMENT:

These Articles of Incorporation may be amended in the manner approved by law. The shares of stock proposed to sell or transfer his shares may not be voted or counted for any purpose at said meeting.



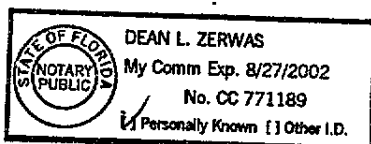
