
ARTICLE VIII



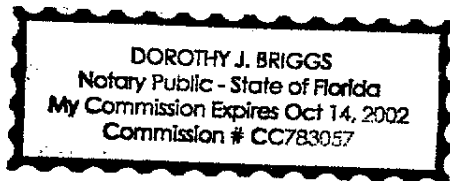
