The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is: New Elja Corporation (the "Corporation").
- SECOND: The principal office address and mailing address of the Corporation is: 4080 Woodridge Road, Miami, Florida 33133.
- THIRD: The corporation is authorized to issues 1,000 shares of common stock, par value \$.00 per share.


