Dear Division Representative,

We recently received notification of dissolution of the above referenced Florida corporation. This is the first year of renewal for the corporation and we were unaware of the renewal requirement in the first year of operation. Additionally, we did not receive a renewal notice in the mail. This is perhaps due to our mail service (other important mail has been either lost or misdelivered during the past year).

In this regard, please accept our apologies. Being a small corporation, it is quite difficult to pay an added \$600.00 (\$750.00 - \$150.00) to restore, rather than renew our corporate filing. We ask that this one time, you allow us to renew our filing for the base filing fee. Our lapse in filing before May 31, 2001, which we now understand is the filing date, was not intentional, but rather due to 1) our lack of knowledge and 2) non-receipt of the information. We would not avoid filing, and would have filed by the deadline had we been aware of this requirement.

If it is not possible to receive this one time reprieve from having to pay this penalty, please advise us and we will forward the balance of the penalty. In this regard we are enclosing herewith the renewal fee of \$150.00 in hopes that we may be forgiven this oversight and assure you it will not happen again.
