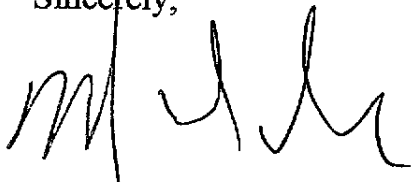

**Articles of Incorporation
Of
COPE PEST CONTROL, INC.**

I, the undersigned natural person, competent to contract, acting as incorporator of a corporation under the general corporation laws of the State of Florida, do make, subscribe, acknowledge and file the foregoing articles of incorporation for such corporation.

ARTICLE I – NAME

The name of the corporation is: COPE PEST CONTROL, INC. The principal place of business is Columbia County, Florida with the mailing address of Post Office Box 266, Fort White, FL. 32038.

ARTICLE II – NATURE OF BUSINESS

This corporation is organized and empowered to: conduct business in, have one or more offices in buy, hold mortgage, sell convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights trademarks, and licenses in the State of Florida and in all other states and countries; to contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, and other evidence of indebtedness, and execute such mortgages, transfers of property or other instruments to secure the payment of corporate indebtedness as required; to purchase the corporate assets of any other corporation and engage in the same or other character of business; to guarantee, endorse, purchase or hold, sell, transfer, mortgage pledge or otherwise acquire or dispose of shares of capital stock or and bonds, securities or other evidence of indebtedness created by any other corporation in the State of Florida or any other state or government, and while owner of said stock to exercise all the rights, powers, privileges of ownership, including the right to vote such stock

The corporation shall principally engage in the business or practice of pest control.

ARTICLE III – CAPITAL STOCK

The amount of authorized capital stock is \$100 consisting of 100 shares of common stock having a par value of \$1.00 per share.

PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash for any new stock of this corporation of any kind, class, or series, shall have the preemptive right to purchase his pro- rata share thereof as nearly as may be done without issuance of fractional shares at the price of which it is offered to others.

VOTING RIGHTS/QUORUM

A quorum of the shares entitled to vote, represented in person or proxy consist of 51% of the shares entitled to vote at any meeting.

LIMITATION OF TRANSFER OF STOCK

No stock in the corporation shall be transferred to a person who is already a stockholder unless the stock shall have been offered in writing for sale to each of the other stockholders in the corporation at the same price and on the same terms as would govern upon a transfer to a person not a stockholder.

ARTICLE V – CORPORATE EXISTENCE

This corporation is to have perpetual existence.

ARTICLE VI – PRINCIPAL OFFICE

The street address of the principal office of the corporation in the State of Florida is Three Rivers Estates – Newark Road, Post Office Box 266, Fort White, Florida 32038-0266.

ARTICLE VII – NUMBER OF DIRECTORS

The number of directors of the corporation shall be set by from time, by the by-laws, but shall be at least two.

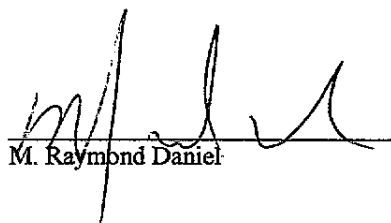

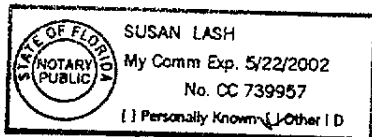
