# ARTICLES OF INCORPORATION OF AL REHMAN HALAL MEAT PRODUCT, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I. NAME
