THE NAME OF THIS CORPORATION IS J T ENTERPRISES OF THAT COUNTY INC.

IN THE EVENT THAT THE CORPORATION IS LEGALLY UNABLE TO PURCHASE SUCH STOCK OR OTHERWISE WAIVES ITS PRIVILEDGE OF PURCHASING, THE SECRETARY OF THE CORPORATION SHALL MAIL A WRITTEN NOTICE TO ALL THE REMAINING STOCKHOLDERS, BY CERTIFIED MAIL, RETURN RECEIPT REQUESTED, ADVISING THEM OF THE TERMS OF SUCH OFFER, AND UNLESS THE TERMS OF SUCH OFFER ARE ACCEPTED BY OR ALL OTHER STOCKHOLDERS WITHIN TEN (10) DAYS FROM THE DATE OF MAILING SUCH NOTICE, THEY SHALL BE DEEMED TO HAVE WAIVED THEIR PRIVILEGE OF PURCHASING, AND THE STOCKHOLDERS OR THE PERSON IN PRIVITY WITH HIM DESIRING TO SELL BE AT LIBERTY TO EFFECT A SALE UPON THE TERMS OF SUCH OFFER.
