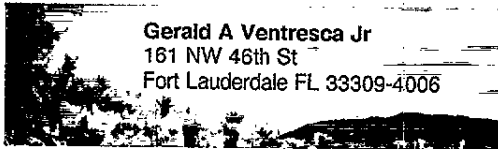

**ARTICLE I
CORPORATE NAME**

The name of this corporation is: JUNGLE JERRY, INC.

**ARTICLE II
NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III
CAPITAL STOCK**

The maximum of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having nominal par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be in money, property, or services. The board of directors shall determine the reasonable value of all consideration, other than money, paid for such shares and their determination, made in good faith, shall be final and conclusive as to such value.

**ARTICLE IV

The beginning date of this corporation shall be the date incorporated by the State of Florida and it shall exist perpetually.

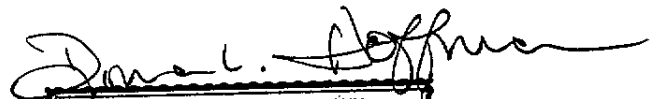
