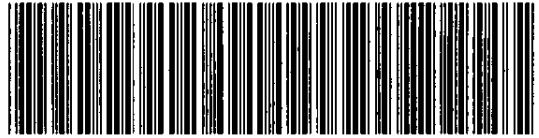



2. The foregoing amendment was adopted by the shareholders of this corporation on December 29, 2009 by unanimous vote.

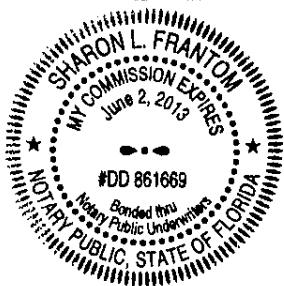


