**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE 1
NAME AND PRINCIPAL OFFICE**

**ARTICLE 2
DURATION**

This corporation shall exist perpetually, commencing upon the date of filing of these Articles of Incorporation
