ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the Corporation shall be: La Mar Restaurants, Inc.

ARTICLE II
PRINCIPAL OFFICE

PURPOSE
