2. That the Corporation was administratively dissolved by the Florida Department of State on 4 October 2002.
3. That the Corporation failed to file its 2002, 2003, 2004, 2005, 2006 Annual Report or pay the 2002, 2003, 2004, 2005, 2006 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:

6. No further ground or grounds exist for the administrative dissolution of the Corporation.
