ARTICLES OF INCORPORATION

OF

NAUGHTON CONSULTING SERVICES, INC.

Pursuant to Chapter 607 of the Florida Business Corporation Act, the undersigned, as the sole incorporator of NAUGHTON CONSULTING SERVICES, INC.
