**ARTICLE I**  
**NAME**

The name of this corporation is NAPPERS, INC.

**ARTICLE II**  
**DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III**  
**PURPOSE**

This corporation is organized for the purpose of transacting any or all-lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**CAPITAL STOCK**


**ARTICLE IX






