ARTICLES OF INCORPORATION 00 SEP 18 AM 10:08

The undersigned Subscriber hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida these Articles of Incorporation, for the purpose of forming a corporation for profit, in accordance with Chapter 607, Florida Statutes, Florida Business Corporation Act.

ARTICLE I - NAME

The name of this corporation is THE TECHNOLOGY GROUP, INC., and the principal place of business and mailing address of this corporation shall be 5804 Breckenridge Parkway, Suites A & B, Tampa, Florida 33610.

ARTICLE II - NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE III - REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of this corporation in the State of Florida is 5804 Breckenridge Parkway, Suites A & B, Tampa, Florida 33610; and the initial registered agent is PAUL R. VASILOFF. The Board of Directors may, from time

to time, move the location of the registered office to any other address in the State of Florida, and may, from time to time, change the registered agent of this corporation.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

This corporation will commence existence upon filing, and exist perpetually thereafter, unless dissolved according to law.

ARTICLE V - CAPITAL STOCK

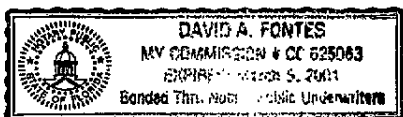


CERTIFICATE OF DESIGNATION


