# ARTICLES OF INCORPORATION OF SIMPLY LAKEFRONT LUXURY, INC.

#### ARTICLE I. NAME

THE NAME OF THIS CORPORATION SHALL BE SIMPLY LAKEFRONT LUXURY, INC.

#### ARTICLE II. COMMENCEMENT AND DURATION

THE COMMENCEMENT OF THIS CORPORATION'S EXISTENCE SHALL BE SEPTEMBER 12, 2000. THIS CORPORATION'S DURATION SHALL BE PERPETUAL.

### ARTICLE III. PURPOSE

THIS CORPORATION IS BEING ORGANIZED FOR THE PURPOSE OF ENGAGING IN THE TRANSACTION OF ANY AND ALL LAWFUL BUSINESS ACTIVITIES PERMITTED UNDER THE LAWS OF FLORIDA AND THE UNITED STATES OF AMERICA.

#### ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue Ten Thousand (10,000), One Dollar (\$1.00) par value shares of common capital stock.

### ARTICLE V. PREEMPTIVE RIGHTS

EVERY SHAREHOLDER, UPON THE SALE FOR CASH BY THIS CORPORATION OF ANY SHARES OF NEW CAPITAL STOCK OF THE SAME KIND, CLASS, OR SERIES, AS THAT WHICH THE SHAREHOLDER ALREADY HOLDS, SHALL HAVE THE PREEMPTIVE RIGHT TO PURCHASE A PRO RATA SHARE THEREOF (AS NEARLY AS MAY BE DONE WITHOUT THE ISSUANCE OF FRACTIONAL SHARES) AT THE PRICE AT WHICH SUCH SHARES ARE OFFERED TO OTHERS.

#### ARTICLE VI. TRANSFER RESTRICTIONS

NO SHAREHOLDER SHALL HAVE THE RIGHT TO SELL, ASSIGN, PLEDGE, ENCUMBER, TRANSFER, OR OTHERWISE DISPOSE OF ANY SHARES OF THE CAPITAL STOCK OF THIS CORPORATION, WITHOUT FIRST OFFERING SUCH SHARES FOR SALE TO THIS CORPORATION AT THE NET ASSET VALUE THEREOF. SUCH OFFER SHALL BE IN WRITING, SIGNED BY THE SHAREHOLDER, SENT BY REGISTERED OR CERTIFIED MAILTO THIS CORPORATION AT ITS REGISTERED OFFICE ADDRESS, AND OPEN FOR ACCEPTANCE BY THIS CORPORATION FOR A PERIOD OF FIFTEEN DAYS FROM THE DATE OF MAILING. IMMEDIATELY UPON EXPIRATION OF THE 15 DAY CORPORATE OPTION THE SHAREHOLDER MUST OFFER HIS STOCK TO THE REMAINING SHAREHOLDERS UPON THE SAME TERMS AND CONDITIONS AS HAD BEEN OFFERED TO THE CORPORATION. NOTICE MUST BE PROVIDED TO EACH SHAREHOLDER, AT THEIR MOST CURRENT RESIDENCE ADDRESS AS IT APPEARS IN THE CORPORATE RECORDS, BY CERTIFIED MAIL-RETURN RECEIPT REQUESTED.

EACH REMAINING SHAREHOLDER SHALL HAVE A PERIOD OF THIRTY DAYS FROM THE DATE OF MAILING THE OPTION NOTICE TO THEM WITHIN WHICH TO GIVE NOTICE, IN THE SAME MANNER AS GIVEN TO THEM, OF EXERCISE OF SAID OPTION. BOTH THE CORPORATION OR ANY REMAINING SHAREHOLDER SHALL HAVE THIRTY DAYS FROM THE DATE OF THEIR MAILING NOTICE OF EXERCISE WITHIN WHICH TO CLOSE AND CONSUMMATE THE STOCK PURCHASE.

IF BOTH THE CORPORATION AND ALL REMAINING STOCKHOLDERS FAIL TO EXERCISE AND CLOSE ON THEIR OPTION TO PURCHASE WITHIN THE TIME PERIODS ABOVE SET FORTH, THEN THE SHAREHOLDER SHALL HAVE THE RIGHT TO DISPOSE OF SUCH SHARES WITHOUT ANY FURTHER RESTRICTIONS.

ON THE DEATH OF ANY SHAREHOLDER, THIS CORPORATION SHALL HAVE THE RIGHT TO PURCHASE ANY SHARE OF THE CAPITAL STOCK OF THIS CORPORATION OWNED BY THE SHAREHOLDER IMMEDIATELY PRIOR TO THE SHAREHOLDER'S DEATH, ON THE TERMS SET FORTH ABOVE, AND THIS PROVISION SHALL BE BINDING UPON THE PERSONAL REPRESENTATIVE OF THE SHAREHOLDER.
