The undersigned, SHUFORD B. MARKS, JR. and POSEY MARKS, subscribers to these Articles of Incorporation, being natural persons over the age of eighteen (18) years of age, competent to contract, hereby presents these Articles for the formation of a Corporation under the laws of the State of Florida.

## ARTICLE I. NAME OF CORPORATION

The name of the Corporation shall be MBS-SUNCOAST, INC.

## ARTICLE II. BUSINESS OF CORPORATION

General Business: This Corporation is organized for the purpose of transacting any and all lawful business, together with and in addition to those powers conferred by the laws of the State of Florida, and the principles of common law upon corporations organized and existing under and by virtue of the laws of Florida.

## ARTICLE X. POWER, PRIVILEGES AND LIMITATIONS

The following special provisions, powers, privileges and limitations shall be applicable to and govern this Corporation, to-wit:

- 10.1 Annual Meeting: The time and place of the annual stockholder's meeting shall be on the second Monday of October of each and every year at the principal place of business of the Corporation, unless otherwise fixed by the By-Laws of this Corporation, and any stockholder thereof may waive notice either before, at or after the meeting.
