ARTICLE I - NAME

The name of this Corporation is CDR Excavating Corp. and the address is 1485 Plymouth Avenue, Mount Dora, Florida 32757.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS
