

ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is Officers of The Lawn, Inc.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100) at the par value of One Dollar (\$1.00) each.

ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of shared consideration of the value of One Thousand Dollars (\$1,000.00) consisting of money, labor done or property actually received.

ARTICLE SIX

The street address of its initial registered office is 5050 Essex Lane, Spring Hill, Florida 34606, and the name of its initial registered agent at such address is Joseph A. Nicora.

ARTICLE SEVEN

It is the intent of the incorporator that the corporation will qualify under Section 1244 of the Internal Revenue Code.

The number of directors constituting the initial board of directors is one and the name and address of each person who is to serve as director until the first annual meeting of the shareholders or until their successors are elected and qualified are:






