
After the events of September 11, 2001, our company experienced a drastic downturn in the tourism industry in Orlando, FL. We were, therefore, forced to close the production office. A temporary **Post Office Box** was established to maintain business, and all mail was sent from the original address in Orlando, FL, to a forwarding station in Lake Mary, FL, then to the Post Office Box. The company has since relocated to new quarters. The original forwarding order was cancelled, and new forwarding info was provided.

Not all of the mail made it to us. Some was sent back to the originator, some was delayed for over a month, and reports from some business contacts is that some never made it at all. I just received a bundle of mail that has been "in transit" which included the Notification of Dissolution.

Under these circumstances, we request your understanding in these matters and ask that you accept the original filing fee of \$150.00.
