The undersigned incorporator of these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

#### ARTICLE L NAME

The name of this corporation is ADAIR & ELIAS CONSULTING, INC.

### ARTICLE II. PURPOSE

his corporation is organized for the purpose of transacting any or all lawful business in the State of Florida.
