**ARTICLES OF INCORPORATION FOR
SJB LIMITED, INC.**

A Florida Corporation

ARTICLE I. NAME

Pursuant to Section 607.0202, the name of the corporation shall be **SJB LIMITED, Inc.**, and shall be referred to in these articles as the "Corporation".

ARTICLE II. PRINCIPAL OFFICE

The initial principal office for the transaction of business of the Corporation within the State of Florida is **5000 Jet Sail Drive, Orlando, FL 32812**. The registered agent at this address is **John D. Smith**.

ARTICLE III. REGISTERED OFFICE

The street address of the initial registered office is **5000 Jet Sail Drive, Orlando, FL 32812**, and the name of the initial registered agent at that address is **John D. Smith**.

ARTICLE IV. NAME OF INCORPORATOR

The name and address of the person signing these Articles of Incorporation is **John D. Smith**.

ARTICLE V. AMENDMENT TO ARTICLES

Amendments to these Articles of Incorporation may be made by a resolution adopted by the Directors of the Corporation.

ARTICLE VI. INITIAL BOARD OF DIRECTORS

The Corporation shall have **3** directors initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one. The names and addresses of the initial Board of Directors are:

ARTICLE VII. SHARES

The total number of shares which the corporation shall have authority to issue is 100 shares of no par value stock.

ARTICLE VIII. ORGANIZATIONAL MEETING

The initial directors named above shall hold an organizational meeting, at the call of a majority of the directors, to complete the organization of the corporation by appointing officers, adopting bylaws, and carrying on any other business brought before the meeting. The director(s) calling the meeting shall give at least three days notice to each director or incorporator.

ARTICLE IX. BY-LAWS

The incorporator or board of directors of this corporation shall adopt initial bylaws for the corporation and amendments to the bylaws shall be by majority vote of the board of directors.

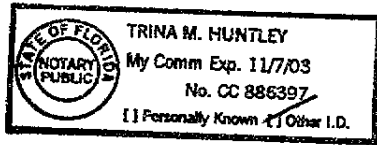

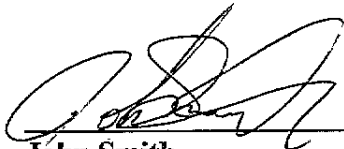
