

ARTICLES OF INCORPORATION OF
S.L.K. TSANOS, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be S.L.K. TSANOS, INC.

The principal address of the corporation at the time of incorporation is 7392 SW 9TH Court, Plantation, Florida 33417.

ARTICLE II. DURATION

The duration of this corporation is perpetual unless dissolved according to law.

Corporate existence shall commence on the date these Articles of Incorporation are filed by the Department of State.

ARTICLE III. PURPOSE


