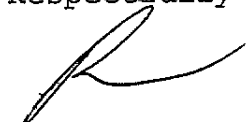

**ARTICLE I - NAME**

The name of the corporation is A-PLUS PROPERTY SOLUTIONS, INC.

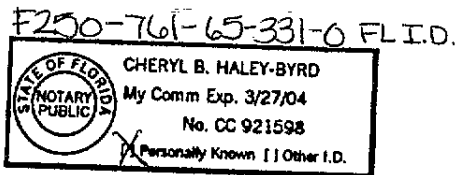
