The undersigned incorporator, RONALD L. SASSANO, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is TRIUMPH BUSINESS SERVICES, INC.

ARTICLE II - PRINCIPAL OFFICE


ARTICLE X - COMMENCEMENT OF CORPORATE EXISTENCE


ARTICLE XI - AMENDMENT
