

Please be advised that the company did not receive the 2001 Uniform Business Report. The company was formed as a result of a separation of the diagnostic physicians from U.S. Oncology, Inc. This separation was negotiated over several months. Apparently, the attorney for U.S. Oncology filed incorporation papers prematurely in October 2000. The actual separation occurred in July 2001.
