**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is **e-TRAINING CENTER.com, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

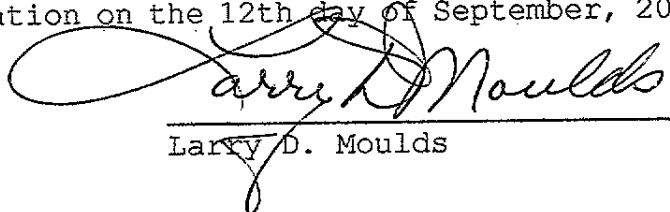
ARTICLE IX - INDEMNIFICATION

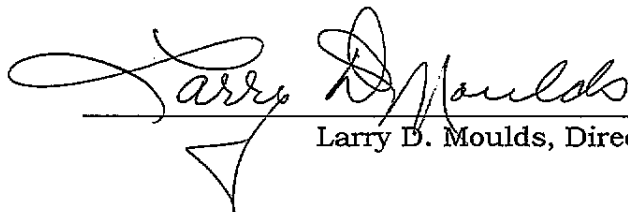

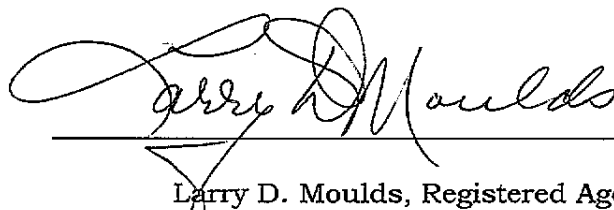
