The undersigned subscriber to these Articles of Incorporation, desiring to form a corporation under the laws of the State of Florida, does hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and hereby adopt the following Articles of Incorporation as the Charter of the corporation hereby organized.

### ARTICLE I NAME AND ADDRESS

The name and address of the Corporation is NELSON & SONS ENTERPRISES INCORPORATED, 3904 Floyd Road, Tampa, FL 33624.

### ARTICLE II

The corporation shall have perpetual existence, commencing with the filing of these Articles of Incorporation, unless terminated earlier.

### ARTICLE III PURPOSES AND POWERS

This corporation is organized for the purpose of engaging in all lawful business activities permitted to a Corporation under the Florida General Corporation Law, as in effect from time to time.
