**ARTICLES OF INCORPORATION
OF
TUMACO INTERNATIONAL INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Tumaco International Inc.

ARTICLE II

The existence of the corporation shall begin on September 21, 2000.

ARTICLE III

The street address of the principal office of the Corporation is 210 West 25th Street, Sanford, Florida 32771.

ARTICLE IV
