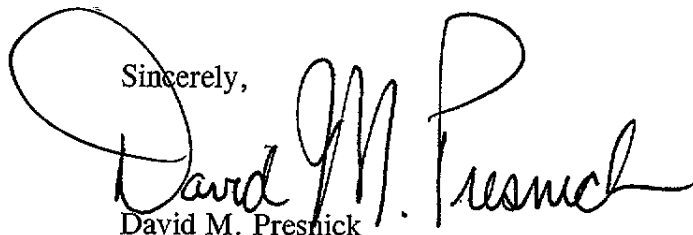

Article 1
Name

The name of the corporation is JOHN H. HEINS & ASSOCIATES, INC.

Article 2
Duration

This duration of this corporation is perpetual. 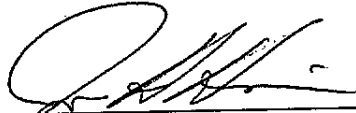
