

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I. CORPORATE NAME**

The name of this corporation shall be **LINERS & COATINGS UNLIMITED, INC.**

**ARTICLE II. INITIAL PRINCIPAL OFFICE**

The street address, and the mailing address of the principal office of the Corporation shall be: 2600 W. 9 Mile Rd., Pensacola, FL 32533. The Board of Directors from time to time may move the principal office to any other address in the State of Florida.

**ARTICLE III. CAPITAL STOCK**

The total authorized capital stock of the corporation shall be 7,500 shares of common stock having no par value. No preemptive rights are to be granted to shareholders.

**ARTICLE IV. REGISTERED AGENT AND INITIAL REGISTERED OFFICE**

## **ARTICLE V. INCORPORATOR**

The name and street address of the person signing these Articles of Incorporation as the incorporator is Frederick E. Pressley, 908 N. Lynch St., Pensacola, FL 32505.

## **ARTICLE VI. BOARD OF DIRECTORS**

This corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholders, but shall never be less than one (1).

This corporation shall have perpetual existence, commencing upon the filing of these Articles.


**ARTICLE X. OFFICERS**


