The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is MIAMI STUDIO FACILITIES, INC.

The term of existence of the corporation is perpetual.

. To engage in the business of television transmission, rental of studio facilities and video recording.

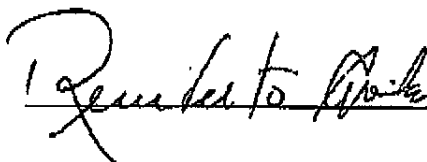
