ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE. FLORIDA

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is TOTAL INTERNATIONAL CAREER CENTER, INC.
